Resolution for the County of Westchester to approve Change Order No. 3 to Contract No. **SUBJECT:**

19-502 with West-Fair Electric Contractors, Inc. for New Switchgear Facility, Playland

Park, Rye, New York, extending the completion date from September 30, 2025 to

June 30, 2026.

By Resolution approved on October 1, 2020, your Honorable Board awarded contract No. 19-502 for New Switchgear Facility, Playland Park, Rye, New York, to West-Fair Electric Contractors Inc., P.O. Box 298, Hawthorne, New York 10532 ("West-Fair"), in the amount of \$4,698,000.00, for the period of October 8, 2020 through September 24, 2023 ("Agreement"). The Agreement was subsequently executed.

Pursuant to the Agreement West-Fair provides all necessary labor, material and equipment required for construction of a new switchgear building at Playland Park, including installation of all transformers, switchgear, electrical panels and all other associated electrical work (the "Project").

Change Order No. 1 in the amount of \$725,448.00 to address field conditions that could not have been determined at the time of design was approved by your Honorable Board by Resolution approved on November 18, 2021.

Change Order No. 2 in the amount of \$700,000.00 was approved by your Honorable Board by Resolution on April 11, 2024 to address Con Edison requirements for conduit encasement, installation of additional conduit and feeder maintenance. During the course of that feeder maintenance work, Con Edison informed the County that the existing relay timing setting on the switchgear required testing and investigation to ensure proper operation of the switchgear. Due to the investigation period and subsequent coordination with Con Edison, additional relay timing adjustments are required and therefore, it is now necessary to extend the term of the Agreement to complete the work.

In order to carry out the work contemplated by this Change Order No. 3 and complete the project, an extension is requested from September 30, 2025 to June 30, 2026. All other terms and conditions of the Agreement shall remain unchanged and in full force and effect.

The Department will track scheduling and accomplishments by West-Fair Electric Contractors Inc. and perform on-site inspections to ensure the successful completion of the work.
