On March 19, 2025, one (1) bid was received and opened for Contract No. PRC-1456 for Service for Water Pumps, Compressors, and Electric Motors, at Various Parks, Recreation and Conservation Facilities, Westchester County, New York.

The bid was reviewed by the Department and it was determined that A&C Furia Electric Motors, Inc. submitted a bid in the amount of \$292,525.00.

RESOLVED, that Contract No. PRC-1456 for Service of Water Rumps, Compressors, and Electric Motors, at Various Parks, Recreation and Conservation Facilities, Westchester County, New York, is hereby awarded to the sole bidder, A&C Furia Electric Motors, Inc, 135 Lafayette Avenue, White Plains, New York 10603, in the amount of \$292,525.00; and be it further

RESOLVED, that as set forth in the Contract No. PRC-1456 6 bid specifications this contract is for a term of execution through December 31, 2027; and be it further

RESOLVED, that this contract is subject to County appropriations; and be it further

RESOLVED, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
