Alphonso J. Cerrato Bus Maintenance Facility Grasslands Campus, Valhalla, New York

The 2025 Capital Budget contains funds for the above referenced project.

The work under this contract consists of all labor, material, and equipment required to remove and replace the existing 2-bay bus wash system and cleaning the reclamation and clean water storage pits, which includes the replacement of piping. Additionally, the project requires removal and replacement of pumps, existing electrical control and equipment panels, as well as associated architectural, structural, electrical and mechanical work.

In accordance with Chapter 635 of the Laws of Westchester County, the Department of Public Works and Transportation has evaluated the needs of this project and determined that a Project Labor Agreement (PLA) will be refit and enhance the interests of the County in the timely and efficient completion of the project. The Contractor to whom this contract is awarded will be required to execute a PLA

The objective of this project is to replace the aging bus wash system at the Cerrato Bus Maintenance Facility, with a new more efficient system.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring the county's buses are cleaned and maintained to meet service standards.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
