Authority to amend a license agreemen with Belizze Impresa LTD for the RE:

> operation of the golf professional concession at Hudson Hills Golf Course, Ossining, New York, in order to exercise the renewal option for the period of

January 1, 2026 through December 31, 2030.

On August 13, 2020 and November 5, 2020, your Honorable Board authorized the County of Westchester ("County") to enter into a license agreement with Belizze Impresa LTD, 22 Ridgeway Avenue, North Salem, New York 10560 ("Belizze") for the operation of the golf professional concession at Hudson Hills Golf Course for the period of January 1, 2021 through December 31, 2025, with the County having the sole option to extend the agreement for an additional five-year term, from January 1, 2026 through December 31, 2030 (the "Agreement"). Under the Agreement, Belizze manages the golf cart operation, provides lessons and rents handpulled carts. In addition, the golf professional collects all golfer fees, including greens fees and golf cart fees and deposits them into a County account

Authority of your Honorable Board is requested to authorize the County to amend the Agreement in order to exercise the renewal option for the period of January 1, 2026 through December 31, 2030. For the privilege of operating the golf professional shop during the renewal term, Belizze w pay to the County the following annual license fees:

The County will pay Belizze a portion of all motorized golf cart rental fees for motorized golf rounds as follows:

Belizze will keep all revenue derived from retail sales in the pro shop and golf lessons. The County will retain the remaining portion of the motorized golf cart revenue as well as all revenue derived from greens fees. All other terms and conditions of the Agreement will remain in full force and effect.

The goal of this agreement is to provide revenue for the County and provide important services for golfers. The objective of this agreement will be tracked and monitored by observations and interactions with staff and site visits.

This agreement is exempt from the Westchester County procurement policy pursuant to Section 3(b), thereof.

Accordingly, approval of the attached resolution by your Honorable Board is most respectfully requested.
