RE: Authority for the County of Westchester to enter into a Grant Agreement with the Federal Transit Administration (FTA) for \$443,655 in Federal Transit Capital Assistance (Grant Agreement NY-2025-065-00)

Authority is requested for the County of Westchester (the "County") to enter into an agreement with the Federal Transit Administration ("FTA") for \$443,655 in Federal Transit Assistance. A 20% County match is required to receive the FTA funds for a total of \$554,569. The funding sources are broken down as follows:

Federal Funds	80%	\$443,655
Local Funds	20%	\$110,914
Total:		\$554,569

Funds received from this grant will be utilized as follows:

Replacement of 40' Hybrid Diesel-Electric Buses (\$443,655 Federal)

Federal funds in this grant are being provided from the Federal Transportation Administration to provide assistance for the procurement of 10 Hybrid Diesel-Electric 40-foot replacement buses, related equipment, vehicle repair spare parts, vehicle inspection tools and vehicle specification review for the BeeLine bus system.

The scope of work includes the following:

- Purchase of 10 Hybrid Diesel-Electric 40-foot buses.
- Procure associated services, bus specification preparation, vehicle inspection, training, tools and parts.

The goal of this project is to reduce the average age of the bus fleet, which will increase vehicle reliability and provide better bus service to the public.

The receipt of Federal funds will be monitored by both the Department of Public Works and Transportation and the Department of Finance.
