RE: Authority to amend a resolution approved on October 30, 2025 concerning an agreement with New-York Presbyterian Westchester Hospital to correct the name of the hospital from New-York Presbyterian Westchester Hospital to The New York and Presbyterian Hospital and correct the commencement date of the agreement from December 1, 2025 to October 1, 2025.

By resolution approved on October 30, 2025 (the "October 30th Resolution"), your Honorable Board authorized the County, acting by and through Westchester Community College (the "College"), to enter into an affiliation agreement with New York-Presbyterian Westchester Hospital for supervised laboratory/clinical education for its Radiology Technology Respiratory Care and Paramedics Program, for a term commencing on or about December 1, 2025, and continuing in full force and effect unless terminated by either party upon written notice (the "Agreement").

Following passage of the October 30th Resolution, the College learned that the correct name of the hospital is The New York and Presbyterian Hospital and the correct commencement date for the agreement is on or about October 1, 2025.

Accordingly, authority is now respectfully requested to amend the October 30th Resolution in order to correct the name of the hospital from New York-Presbyterian Westchester Hospital to The New York and Presbyterian Hospital and to correct the commencement date of the agreement from on or about December 1, 2025 to on or about October 1, 2025.

Except as specifically amended hereby, all other terms and conditions set forth in the October 30th Resolution shall remain the same.

Accordingly, approval of the attached resolution is most respectfully requested.
