SUBJECT: Resolution for the County of Westchester to approve Change Order No. 1 to Contract No.

22-523 with Mace Contracting Corporation for Infrastructure Penabilitation – Phase 3, Playland Park, Rye, New York in the amount not to exceed of \$8,405,000.00 increasing the

total contract amount to \$30,762,000.00, and extending the completion date from

October 28, 2026 to December 31, 2026.

On December 8, 2022, your Honorable Board awarded Contract No. 22-523 for Infrastructure Rehabilitation – Phase 3, Playland Park, Rye, New York in the amount of \$22,357,000.00 to Mace Construction Corporation ("Contractor").

The work under this contract consists of providing all necessary labor, material and equipment required for the restoration of the Historic Dragon Coaster Station, the Park's two Historic Arcade Buildings along with the West Cross-Axis Games and Food structures. The work includes all associated mechanical, plumbing and electrical work.

During the course of construction, it was discovered that several structures and components under and connected to the Dragon Coaster Station, Cross-Axis Buildings, Burger Barn Building and Colonnade area of the project were in serious disrepair. Specifically, Cross-Axis Buildings D and F were found to have deteriorated foundations. Cross-Axis Buildings E and F were found to have degraded structural conditions, the Cross-Axis area was found to have insufficient storm water management, and the Dragon Coaster Station and facility were discovered to have degraded roof and structural elements. In order to ensure continued safe operation, it is essential to undertake additional structural, mechanical, electrical, and plumbing rehabilitation efforts, including the replacement of degraded structural members, installation of storm water infrastructure and replacement of critical parts and components. These conditions were not known at the time of bid and were discovered during construction.

The cost of this additional work is estimated to not exceed \$8,405,000.00 and is based upon Contractor's unit price labor rates, unit price equipment rates and unit price rates of material, which have been reviewed and approved, by the Department of Public Works and Transportation ("Department"). The scope of work for this unexpected event could not have been anticipated at the time of bid, and therefore a Change Order to Contract 22-523 is hereby requested.

The Department will track scheduling, actual costs and accomplishments and perform on-site inspections to ensure the successful completion of the work under Change Order No. 1.

This additional work is incidental to the original work and does not materially alter the main purpose of the contract so as to constitute a new undertaking. The work is of the same nature as the initial work, is to be performed in the same general vicinity, is necessary to efficiently complete the project and was unanticipated until work under the contract commenced. Based on the above, the County seeks anthority from your Honorable Board to not only increase the contract amount by an additional \$8,405,000.00 but also extend the term of the Contract No. 22-523 from October 28, 2026 to December 31, 2026. All other terms and conditions of the Contract No. 22-523 shall remain unchanged and in full force and effect.

WHEREAS, Hugh J. Greechan, Jr., P.E., Commissioner of Public Works and Transportation, requests approval of Change Order No. 1 on Contract No. 22-523, between the County of Westchester and Mace Contracting Corporation (MBE), New Rochelle, New York, for Infrastructure Rehabilitation – Phase 3, Playland Park, Rye, New York

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
