SUBJECT: Authority to exercise the County's option to extend the term of an agreement with Barclay

Water Management, Inc. for one two (2) year option period, thereby increasing the amount of the agreement by \$320,576 and extending the term of the agreement through

May 31, 2027 (Contract No. 21-209)

By resolution approved on April 21, 2022 (the "April 21st Resolution"), your Honorable Board awarded Contract No. 21-209 to Barclay Water Management, Inc. ("Barclay"). The April 21st Resolution authorized the County of Westchester (the "County") to enter into Contract No. 21-209 with Barclay, pursuant to which Barclay was to provide Countywide Water Treatment Services, Westchester County, New York in the amount of \$480,864, for the period from June 1, 2022 through May 31, 2025, ("Contract No. 21-209" or the "Agreement"), with the County having the sole option to extend the Agreement for one two (2) year option period.

The County now seeks authority from your Honorable Board to 1) exercise the two (2) year renewal option and extend the termination date of the Agreement from May 31, 2025 to May 31, 2027; and 2) increase the amount of the Agreement by \$320,576 from an amount of \$480,864 to a new total amount not to exceed \$801,440.

All other terms and conditions of the April 21st Resolution and the Agreement shall remain in full force and effect and unchanged.

This contract is in the public's best interest because it will promote the health and safety of the general public by preventing bacterial growth and corrosion of the systems using environmentally friendly chemicals and will reduce the County's annual maintenance costs.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

RESOLVED, that the County is authorized to 1) exercise its two (2) year renewal option for Contract No. 21-209 with Barclay Water Management, Inc., Newton, Massachusetts to provide a Countywide Water Treatment Services, Westchester County, New York and extend the termination date of the Agreement from May 31, 2025 to May 31, 2027; and 2) increase the amount of the Agreement by \$320,576.00 from an amount of \$480,864.00 to a new total amount not to exceed \$801,440.00; and be it further

RESOLVED, that except as specifically amended hereby, alternaining terms and conditions of the April 21, 2022 Resolution and the Agreement shall remain in full force and effect and unchanged; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute all documents and take all actions necessary to effectuate the purpose hereof.
