SUBJECT: Authorization to amend an agreement with the law firm of Tromberg, Morris & Poulin,

PLLC for the provision of legal services in an "of counsel" capacity to the County Attorney in connection with the recovery of delinquent student accounts at Westchester

Community College in order to change the name of the law firm to Tromberg, Miller,

Morris & Partner, PLLC

Pursuant to a Resolution approved on October 12, 2023, the County of Westchester (the "County") entered into an agreement with the law firm of Tromberg, Morris & Poulin, PLLC to provide legal services, in an "of counsel" capacity to the County Attorney in connection with the recovery of delinquent student accounts at Westchester Community College, for a term of September 1, 2023 through August 31, 2028, with the County having the sole option to extend the agreement for three additional one-year terms (the "Agreement").

Recently, the County was informed that effective June 26, 2025, the law firm's name has been changed to Tromberg, Miller, Morris & Partner, PLLC. We are advised that this is a name change only and the same attorneys and support staff will be used to perform the work, thus guaranteeing continuity throughout the Agreement. Except as specifically amended hereby, all other terms and conditions of the Agreement shall remain changed.

Therefore, approval is requested to amend the Agreement to reflect the law firm's new name of Tremberg, Miller, Morris & Partner, PLLC.
