Authority is respectfully requested from your Honorable Board for the County of Westchester (the "County") to enter into a grant agreement with New York State, acting by and through its Division of Homeland Security and Emergency Services, ("DHSES") in order to accept a grant awarded to the County by DHSES under New York State's FY21 Cyber Security Grant Program, in the amount of Fifty Thousand Dollars (\$50,000.00), for the period from April 1, 2024 through August 31, 2025, for eligible cyber security expenses (the "Grant Agreement"). Funding for this initiative is provided by the U.S. Department of Homeland Security's (DHS) State Homeland Security Grant Program (SHSP) and is administered by DHSES.

The proposed Grant Agreement will serve a public purpose by making available to the County certain additional, federal funds that the County can use for eligible cyber security expenses.
