On July 2, 2025, the County of Westchester ("County") received and opened four (4) bids for Contract No. 23-502 Playland Pumping Station Rehabilitation, Blind Brook Sewer District, Rye, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Mace Contracting Corporation (MBE) submitted the low bid in the amount of \$8,393,000.00. The objective of this project is to replace and upgrade the County-owned sewage pumping station, which suffers significant wear and tear due to constant use. The upgrade not only covers necessary replacement and rehabilitation, but also improves efficiency of the pumping station by reducing energy and Manpower costs, as well as improves the operational performance and reliability of the facility. The Department is required to keep its water and wastewater treatment facilities in a state of good repair in accordance with State and Federal regulations.

This contract is in the public's best interest because it ensures that the facility meets ongoing operational needs and complies with current building codes.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 23-502 be awarded to Mace Contracting Corporation (MBE) in the amount of \$8,393,000.00.
