**SUBJECT:** Request for Authority to Solicit Bids by Public Advertisement for Six (6) Moving Services Contracts for Voting Machines, E-Poll Books and Printers, Cabinets, PPE, Supply Bags and Privacy Booths and Periphral Markers between the County Warehouse and Various Polling Place Locations for all **2025** and **2026** Primary, Special, and General Elections covering Zones 1 through 6 (BOE 24M(Z-01), BOE 24M(Z-02), BOE 24M(Z-03), BOE 24M(Z-04), BOE 24M(Z-05) and BOE 24M(Z-06).

Attached for your consideration is a Resolution which, if approved by your Honorable Board, would authorize the Board of Elections to solicit bids by public advertisement for six (6) moving services contracts for voting machines, E-Poll books and printers, cabinets, PPE, supply bags, privacy booths and periphral markers for Zones 1 through 6, (BOE 24M(Z-01), BOE 24M(Z-02), BOE 24M(Z-03), BOE 24M(Z-04), BOE 24M(Z-05) and BOE 24M(Z-06)) respectively, between the County Warehouse and various polling place locations in the County of Westchester (the "County") for all 2025 and 2026 Primary, Special and General Elections. These six (6) contracts will commence on or about January 1, 2025 and terminate on December 31, 2026.

Since the final number of the voting districts that are holding primaries has not yet been determined, the County will receive a pro-rata credit based upon the number of polling places in each zone that are ultimately used in the Primary and Special Elections.

The public purpose, as well as the goal and objective of this contract, is to allow the Board of Elections to carry out its statutory duties in connection with all upcoming 2025 and 2026 Primary, Special and General Elections and to ensure that all eligible County residents have the opportunity to exercise their right to vote.

Pursuant to applicable law, the County is required to store, transport and secure voting machine equipment in connection with all Primary, Special and General Elections. Due to the large number of voting machines, supply bags and privacy booths that must be transported to and from polling place locations, this service is best handled through an outside vendor as the County does not have sufficient staff to carry out this work. By having such a contract in place, the County will be able to carry out its statutory duties in connection with the upcoming 2025 and 2026 Elections.

The successful bidder will be required to provide security in form of a certified check in the amount of two percent (2%) of the total Lump Sum Bid for the faithful performance of each of the contracts. The performance of the successful bidder under this contract will be monitored by the staff of the Board of Elections to ensure compliance with contract terms.

Approval of the attached resolution is respectfully requested.
