The 2025 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment to mill and resurface the roadway with all associated work. It also includes curbing, guide rail replacement, drainage structure adjustments, frames/grates repairs and replacements, and new pavement markings.

The objective of this contract is to replace substandard areas of asphalt paving and improve roadside conditions.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring County roads meet current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

and be it further

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance and payment bond in an amount equal to 100% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
