The 2024 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment to mill and resurface asphalt pavement overlay. It also includes full depth repairs as needed, replacement of curb cuts for ADA compliance, replacement of some curbing and driveway aprons, drainage structure adjustments and repairs, as well as replacement of traffic signal loops, new pavement markings and associated work.

The objective of this contract is to replace substandard areas of asphalt paving and improve roadside conditions.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring the various County roads meet current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
