WC Taxi and Limousine Commission

I. Meeting Called to Order

Chairperson Leandra Eustache called the meeting to order at 10:07 a.m. and noted board member attendance as follows:

Present: Leandra Eustache, Morton David, Sean Meade, Jorge Rodrigues, Edward Stoppelmann, and Terence Toal

Absent: Phil Raffiani, Millie Becker and John Khader

Newly-appointed board member, Sean Meade, introduced himself to the board and was very much welcomed by the rest of the board. Chairperson Eustache noted that given Sean's very important role in the hospitality industry, she believes that he will bring very useful input to the Commission.

Chairperson Eustache moved to excuse the absence of Jorge Rodrigues from the February 17, 2022 meeting in light of the fact that he had informed the board that he would be traveling at the time of the meeting. Ed Stoppelmann seconded the motion which passed by a majority. Jorge abstained and all other members voted to in favor of the motion.

Chairperson Eustache also moved to excuse the absences of John, Millie and Phi for the instant meeting in light of the date change for the meeting. Terry Toal seconded the motion which passed unanimously.

II. Approval of February 17, 2022 Meeting Minutes

Motion to approve by Morton David, seconded by Terry Toal. Motion passed unanimously.

III. Public Speaking

Chairperson Eustache noted that the meeting was being live streamed but that no members of the public had registered to offer public comment.

IV. Old Business

A. Booting & Scofflaw Update

The Booting and Scofflaw update was delivered by TLC Enforcement Officers who noted that there was \$50,090 in fees collected in February 2022 as a result of 19 TLC impounds and \$10,100 in additional scofflaw payments, bringing the total scofflaw payments collected for the year to \$64,690.

B. Monthly Revenue Report

Board members reviewed the Commission's Monthly Revenue Report for January and February 2022. Chairperson Eustache noted an overall 14-percent decrease in revenue in January 2022 as compared to January 2021 and an overall 16-percent increase in revenue for February 2022 as compared to February 2021.

B. ALJ Recommendations

1. June 22, 2021 - Formal Hearings (newly-added decisions)
Discussion: WCTLC v. 1st Choice Taxi and Limo Inc.

Chairperson Eustache explained that the board is being asked to consider newly-added ALJ recommendations from formal hearings that were held on June 22, 2021. The written recommendations pertain to a series of matters against 1st Choice Taxi and Limo and associated respondents. Post-trial memos were submitted by the respondents and TLC.

Respondents had stipulated to the facts in each matter but were challenging TLC's authority to issue tickets to 1st Choice's taxis as a result of the taxi exemption in the for-hire vehicle law. 1st Choice's attorney also argued that TLC Enforcement Officer K. Marco wrongfully targeted respondents as a result of information from the New Rochelle Police Department regarding the revocation of 1st Choice's medallions and that the ALJ recommendations should be deferred until the final disposition of an Article 78 proceeding filed by a separate respondent--Splendid Taxi. Although a decision had already been made in the Splendid matter, a motion to reargue was pending at the time of 1st Choice post-hearing memo and its attorney argued that the 1st Choice hearing recommendations should be deferred until there was a motion decision and appeal decision in the Splendid matter.

TLC's post hearing memo argued that it was not overreaching its authority in

issuing tickets to 1st choice taxis that were operating with revoked medallions and/or outside of their licensing jurisdiction. TLC also denied any wrongdoing by Officer Marco in sharing information with New Rochelle PD and argued that deferring the ALJ recommendations pending the outcome of a proceeding that does not involve 1st Choice was impractical and improper.'

After considering the entire record, ALJ Bill Gianaris issued a series of report and recommendations finding that TLC was not overreaching its authority. ALJ Gianaris then made recommendations regarding the guilt of 1st Choice based on the facts of each individual stop and there were the recommendations before the board today.

After an initial motion by Mort David was raised, seconded by Jorge Rodrigues and passed, Ed Stoppelmann made a motion to reopen it because the motion language referred to the Splendid matter and Ed thought it was best for it to be clear that the board's decision in the 1st Choice matters was in no way contingent upon the Splendid Article 78. Jorge Rodrigues seconded the reopening motion which passed. After some cross discussion, Jorge Rodrigues made a motion to approve the 1st Choice decisions with no language referencing the Splendid matter. Terry Toal seconded that motion which passed by a majority with all members voting in favor except Chairperson Eustache who abstained in light of her having contributed to the post-hearing memo for TLC.

Motion to approve by Jorge Rodrigues, seconded by Ed Stoppelmann. Motion passed unanimously.

3. March 9, 2022 - Formal/Informal Hearings

Motion to approve by Jorge Rodrigues, seconded by Mort David. Motion passed unanimously.

March 15, 2022 - Formal Hearings
 Discussion: Request for Reconsideration in matter of WCTLC v.Spledid Taxi

Motion to reject Splendid's request to reconsider and approve the ALJ recommendations by Mort David, seconded by Jorge Rodrigues. Motion passed unanimously.

5. March 16, 2022 - Informal Hearings

Motion to approve by Morton David, seconded by Ed Stoppelmann. Motion passed unanimously.

6. March 23, 2022 - Informal Hearings

Motion to approve by Ed Stoppelmann, seconded by Jorge Rodrigues. Motion passed unanimously.

VII. Open Discussion of Items of General Interest

Chairperson Eustache explained that TLC is preparing for prom season and are hoping that the prom schedules will be close to normal this year. Chairperson Eustache also

shared that TLC had a new liaison with the 9th floor, Karen Pasquale and that the TLC service window will reopen soon.






