NOTEWORTHY EVENTS IN MOUNT KISCO DURING THE MONTH OF JUNE, 2022

- 06/01/2022 – Case#1552-22 – The District Loss Prevention Manager from T.J. Maxx, 506 Main St., reported a larceny in the past where an unknown male cut several security tethers and stole several high end handbags valued at \$8,869.95. Security footage was obtained. Investigation Pending.
- Officers assigned to Mount Kisco made (4) arrests this past week for Assault, Larceny, Bench Warrant, and DWI. Case#1535, #1564, #1584, and #1595
- From June 6th-10th, Officers responded to several locations within the Village for larcenies of catalytic converters. The thefts were from residents' private vehicles and appeared to have been take during the overnight hours. Case#1599, 1606, 1629, 1630, 1633, 1637, and 1640-22. Investigations Pending.
- From June 12 – June 18th, Officers responded to (4) more reports of stolen catalytic converters from parked motor vehicles. The thefts occurred on Barker St, Woodcrest Ln., and the TJ Maxx parking lot (Main St.). The targeted vehicles appeared to be older models of Honda/Acura. Case#1667, 1670, 1701, and 1731-22.
- 06/29/22 - Case#1842-22 – Officers located a vehicle wanted for Robbery, including a firearm, out of Putnam County in front of 162 Main St. Mount Kisco. Officers took custody of the operator without incident and turned him over to Putnam County Sheriff's Department.
- Byram Lake enforcement issues. PO Camacho issued 17 FAT (field appearance tickets) for Trespass. CRO and patrol officers conducted routine directed patrols.
- LT. Reich, Sgt. Dress and CRO Ramirez met with MKFD Chiefs on a variety of issues to further enhance our partnership and joint training initiatives.

MOUNT KISCO PRECINCT COMMUNITY RESOURCE OFFICER (CRO) - NOTABLE ACTIVITY

- Mitigated a situation and confusion where trespass summonses were being written to the wrong court near the Byram Lake - Mount Kisco Reservoir. Worked with the issuing officer and Mount Kisco Court to correct the situation.
- Coordinated and facilitated a community meeting at St. Francis Church with Mental Health Association, Mayor, Deputy Mayor, and members of the community to discuss community concerns.
- Consulted with St. Francis Church Religious Education Director and provided available resources in dealing with youth and mental health services. Began putting together "Cookout with Cops" event with the Director to be held in July.
- Worked with parents and youth to get to the bottom of an on-going issue between groups of youths threatening and fighting with each other on a constant basis. Youths were from both Fox Lane HS and Hillside Alternative School. Mitigation efforts were successful with a trespass letter being issued and consistent follow ups with a mother and her son, who was the root of the problem.
- Attended 'Coffee with Seniors' at Pinecrest Manor and initiated planning for National Night Out activities at Pinecrest.
- Attended meeting with the Northwell Health Community Care team and was able to provide information regarding people who I was familiar with that are on their radar for more in depth care. Assisted Northwell Health with a paraplegic female patient who is deaf, non-verbal and homeless.
- Conducted a Security Assessment with Camp Iroquois to find ways to harden their buildings and evaluated their emergency plans in the event of an active shooter or some other significant incident that could risk the safety of the campers. Provided a detailed security assessment and recommendations to Camp Directors.
- Worked with Officer Camacho, Officer Grasso, and the DPW dept to focus on traffic safety. "Slow the Roll" campaign initiated.
- Helped to resolve a neighbor dispute at Pinecrest Manor over parking spaces and had to coordinate with Pinecrest Manor Director, Village Managers in regards to enforcement and the possible creation of 1 or 2 handicap parking spaces in the upper lot that took a few days.
- Assisted the Mount Kisco ADA with locating a subject they could not find in order to move forward with their case in court. I located said subject in the woods where he and other homeless males like to congregate. I then put him in contact with ADA. Days later, I responded to the ADA's office to assist them with translation for the subject to provide them with additional information about the case.
- Continued outreach and enforcement of drinking in public and trespass violations.
- Participated in MKES graduation ceremony with First Responder Salute with Sgt. Dress, precinct patrol officers, MKFD and MKVAC. Participated in MKES Field Day with PO Camacho.
