AMOMD SCITTED. SECRETARY Request for Authorization to Settle the Lawsuit Progressive Specialty Insurance Re:

Company as subrogee of Juan Farias Sanchez v County of Westchester in the

amount of \$11,084.57.

Attached for your consideration is a resolution which, if approved by your Honorable Board, would authorize settlement of the lawsuit Progressive Specialty Insurance Company as subrogee of Juan Farias Sanchez v. County of Westchester.

This was a lawsuit filed by Progressive Specialty Insurance Company as subrogee of Juan Farias Sanchez against the County for property damage caused by a County vehicle to Mr. Sanchez's vehicle parked on the side of the street. At the time of the accident, the County vehicle was making a left turn onto 2nd Street in New Rochelle when it struck Mr. Sanchez's vehicle with the passenger side rear stanchion/stabilizer which had accidentally extended outward. According to the driver of the County vehicle, the safety pin that locks the stanchion/stabilizer in place had popped out, resulting in it being released. In addition, two other vehicles were also struck, however, they are not part of this claim. Based upon the circumstances of this accident, there is 100% total liability assigned to the County.

No claim has been made for personal injuries. However, a claim has been made by Progressive for the property damage to Mr. Sanchez's vehicle, in the amount of \$11,084.57. The total cost of the damage to Mr. Sanchez's vehicle was \$11,949.94. Progressive incurred \$623.14 in car rental expenses, but received \$1,488.51 in salvage value for the motor vehicle, bringing the total remaining damage cost to \$11,084.57, which is the amount Progressive is seeking in this case.

Plaintiff is represented by Jodi P. Feldman, of Feldman & Feldman, LLP, 811 West Jericho Turnpike, Suite 201W, Smithtown, New York 11787.

In light of the nature of the property damage and the liability assessment, a settlement of \$11,084.57 is proposed, and plaintiff's counsel has indicated that such an amount would be acceptable to plaintiff.
