Re: Request for Authorization to Settle the Lawsuit of Zhianni Spears v. The

County of Westchester et al, in the amount of \$50,000.

Attached for your consideration is a resolution which, if approved by your Honorable Board, would authorize settlement of the lawsuit entitled <u>Zhianni R. Spears v. The County of Westchester, et al.</u>

The circumstances of this Liberty Lines bus accident case are as follows. On June 30, 2018, in Yonkers, plaintiff opened her car door into a traffic lane and trapped her hand between her car door and the bus. Plaintiff was a passenger in a friend's car. The bus driver testified at his examination before trial that he did see the plaintiff walk between her car (which was illegally parked in a bus stop), and the bus, but nevertheless pulled out with the plaintiff in that dangerous position.

Specifically, the bus driver testified that he looked in the right side view mirrors before he moved the bus. He pulled forward and, while he was moving, plaintiff went around the back of the car, up between the vehicles, and opened the door into the side of the bus. Unfortunately, the video establishes that plaintiff went around the back of the parked car and was in a blind spot between the two vehicles while the bus was stopped. After she was in that position, the bus pulled forward.

Both plaintiff and the driver are likely to be found to have been a proximate cause of the accident.

The driver is no longer employed by Liberty Lines.

Plaintiff's injuries were a fracture with open reduction and internal fixation of the left index finger. There is scarring at the surgical site. She also had lacerations to the base of her thumb and index finger that were sutured. She has some reduction in range of motion of the finger.

In light of the nature of Plaintiff's injuries, and the likelihood that a jury may believe that the operator of the Liberty Lines bus was negligent in failing to see the plaintiff, and that his actions were the proximate cause of plaintiff's injuries, a settlement of \$50,000.00 is proposed, and Plaintiff's counsel has indicated that such an amount would be acceptable to Plaintiff.
