RE: Resolution authorizing the County of Westchester to enter into a grant

agreement with the State of New York to accept funding to implement the Early Voting Expansion Grant in the amount of \$67,455.21 for the term

April 7, 2021 through January 28, 2022.

Authority is requested for the County of Westchester ("County"), acting by and through its Board of Elections (the "BOE"), to enter into a grant agreement with the State of New York (NYS Contract No. C004456) to accept Early Voting Expansion Grant funding in the amount of \$67,455.21, payable on a reimbursement basis, for the term commencing on April 7, 2021 and terminating on January 28, 2022.

The State of New York, acting by and through the New York State Board of Elections has allocated to Westchester County these funds which are to be utilized to provide early voting at poll sites in Westchester County.

The public purpose of the proposed agreement is to facilitate the purchase of necessary equipment, use of poll sites, payment of election inspectors and staff to ensure that early voting will be available in poll sites across Westchester County. Utilizing grant funding will alleviate the need for the use of County tax dollars for this purpose.
