OF Authority to amend an agreement with Huron Consulting Services, LLC wherein Re: Huron will assist Westchester Community College to implement a new financial planning aid system to improve efficiency and provide students with an easier process for receiving federal aid, state aid, and scholarships, in order to adjust the term of the agreement.

By resolution approved on October 7, 2021, your Honorable Board authorized the County of Westchester ("County"), acting by and through Westchester Community College (the "College") to enter into an agreement with Huron Consulting Services, LLC ("Huron") for the provision of professional consulting services to assist WCC in implementing a new financial planning aid system to improve efficiency and provide students with an easier process for receiving federal aid, state aid and scholarships, for a term commencing on October 1, 2021 and expiring one year later, in an amount notto-exceed Five Fundred and Twenty-Two Thousand (\$522,000) Dollars (the "Agreement" The Agreement was subsequently executed.

Because the Agreement was not fully executed and approved until January 18, 2022 There was a delay in the commencement of services. In order to provide Huron with additional time to complete the services, authority is now requested to amend the Agreement in order to adjust the term thereof to start on or about February 7, 2022 with the Agreement to expire on or about December 31, 2022. In addition, authority is requested to amend the payment schedule to coincide with the new term of the Agreement.

All other terms shall remain the same.
