RE: Request for authority for the County of Westchester to enter into Agreements with the

Westchester Jewish Community Services, Inc. and the Young Women's Christian Association of Yonkers to administer nutrition and nutrition related programs for the elderly pursuant to Titles IIIC-1, IIIC-2 and NSIP of the Older Americans Act in an aggregate amount not-to-exceed \$36,800, for the program period commencing on January 1, 2022 and continuing through December 31, 2022, noting that program period for NSIP shall commence retroactive to October 1, 2021 and continue through

September 30, 2022.

The County of Westchester, acting by and through its Department of Senior Programs and Services (the "Department"), seeks authority from your Honorable Board to enter into agreements (the "Agreements") with the Westchester Jewish Community Services, Inc. ("WJCS") and the Young Women's Christian Association of Yonkers ("YWCA of Yonkers") collectively (the "Contractors"), to administer nutrition and nutrition-related programs (the "Programs") for the elderly pursuant to Titles IIIC-1, IIIC-2 and NSIP of the Older Americans Act. Federal funding for the Programs shall be for a total aggregate amount not-to-exceed \$36,800 in the individual amounts set forth in the attached Schedule "A" for the program period commencing on January 1, 2022 and continuing through December 31, 2022, noting that program period for NSIP shall commence retroactive to October 1, 2021 and continue through September 30, 2022. The Contractors are required to contribute an aggregate amount not to exceed \$10,415 to the III-C Programs in the individual amounts also set forth in the attached Schedule "A."

With regard to the distribution of NSIP funding, the Agreements with the Contractors will provide that the Department will be authorized to distribute such funding 1) contingent upon its receiving further State approval; and 2) by providing the Contractors with written confirmation that the State has authorized the distribution of such funds, without the need for the subcontractor to execute a supplemental agreement. This practice was approved by your Honorable Board in 2010 to avoid the administrative difficulties involved in distributing NSIP funds prior to the State-imposed deadline.

The NYSOFA Agreement and the Agreement with the Contractors will serve a public purpose by providing needed nutrition programs to elderly residents of the County, thus preventing malnutrition and improving their overall health.

The goals and objectives of the nutrition programs under Titles IIIC-1, IIIC-2 and NSIP of the Older Americans Act are to service seniors who are 60 years of age or older looking to satisfy the basic need for food, nutrition and socialization. The home-delivered meals program specifically aims to maintain or improve the wellbeing of those seniors who are at increased nutritional risk.

The goals and objectives are in the best interests of the County in terms of public health by providing needed nutrition programs to elderly residents of the County who are most vulnerable to suffering from malnutrition.

The goals and objectives will be tracked, monitored and evaluated by the Department's Nutrition, Health and Wellness Unit, to ensure compliance with Federal, State and County Regulations. Onsite monitoring, subcontractor monthly report reviews and contract meal performance management will be completed by assigned nutrition staff. On-site reviews will be conducted bi-annually by nutrition staff and annually by the State Office for the Aging.

The Agreements with the Contractors for provision of the Programs are exempt from the County Procurement Policy pursuant to Section 3(a) xix thereof which exempts contracts for direct services to senior citizens. In addition, the Agreements with the Contractors constitute non-competitive procurements under the Federal procurement regulations in accordance with 2 CFR§ 200.320 (c)(2), in that due to the nature and extent of the services being provided by the Contractor, that these services are only available from those single sources.

Accordingly, I most respectfully recommend adoption of the attached proposed resolution.

RESOLUTION

Upon communication from the Commissioner of the Westchester County Department of Senior Programs and Services:

- RESOLVED, that the County of Westchester (the "County") acting by and through its Department of Senior Program and Services (the "Department") is hereby authorized to enter into agreements (the "Agreements") with the Westchester Jewish Community Services, Inc. ("WJCS") and the Young Women's Christian Association of Yonkers ("YWCA of Yonkers") (collectively the "Contractors") to administer nutrition and nutrition-related programs (the "Programs") for the elderly pursuant to Titles IIIC-1, IIIC-2, and NSIP of the Older Americans Act for a total aggregate amount not-to-exceed \$36,800 in the individual amounts set forth in the attached Schedule "A", for the program period commencing retroactive to January 1, 2022 and continuing through December 31, 2022, noting that the period for NSIP shall commence retroactive to October 1, 2021 and continue through September 30, 2022; and be it further
- **RESOLVED**, that the Contractors are required to contribute an aggregate amount not-to-exceed \$10,415 to the Programs in the individual amounts set forth in the attached Schedule "A"; and be it further
- RESOLVED, that with regard to the distribution of NSIP funding, the Agreements with the Contractors shall provide that the Department will be authorized to distribute such funding 1) contingent upon its receiving State approval; and 2) by providing the Contractors with written confirmation that the State has authorized the distribution of such funds, without the need for each Contractor to execute a supplemental agreement; and be it further
- **RESOLVED**, that the Agreements with the Contractors are subject to County Appropriations; and be it further
- RESOLVED, that the Agreements with the Contractors are also subject to the further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of the Agreements. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate the Agreement with each Contractor or renegotiate the amount and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractors, then the Contractors shall have the right to terminate their respective Agreement upon reasonable prior written notice; and be it further
- **RESOLVED**, that the County Executive or his duly authorized designee be, and hereby is, authorized to take such actions and execute such documents as may be necessary and appropriate to effectuate the purposes hereof.
