- SCULA SECRETARY SUBJECT: Resolution authorizing an amendment to an agreement between the County of Westchester and Volunteers of America Greater New York, Inc. to provide upgrades to the cooling and ventilation system at the Homeless Shelter in Valhalla, NY for a term commercing on June 1, 2022 and continuing through September 30, 2022 in an amount not-to-exceed \$457,035.00, in order to change the privation date from September 30, 2022 to March 31, 2023.

On June 2, 2022, your Honorable Board approved a resolution that, inter alia, authorized the County of Westchester (the "County") to enter into an agreement with Volunteers of America Greater New York, Inc. ("VOA"), pursuant to which VOA agreed to provide upgrades to the cooling and ventilation system at the Homeless Shelter in Valhalla, NY by installing a new HVAC system, for a term commencing on June 1, 2022 and continuing through September 30, 2022. In consideration for services rendered, the County agreed to pay the XOA an amount not-to-exceed \$457,035.00 with funds provided under a grant from the Emergency Solutions Grant COVID-19 ("ESG-CV") program. (the "Agreement"). The Agreement was subsequently executed.

The parties now desire to amend the Agreement in order to change the contract expiration date from September 30, 2022 to March 31, 2023, as VOA needs additional time to complete the upgrade of their HVAC system due to delays caused by global supply issues and the semiconductor chip shortages.

Except as specifically provided hereby, all remaining terms and conditions of the Agreement shall remain in full and effect.

The goal and objective of this agreement is to provide improvement to the homeless shelter for a safe environment for those in the in the Shelter in Valhalla, NY. The project will be monitored by the Westchester County Department of Planning staff, who will review all payment requests to ensure all contractual requirements are met.

I recommend approval of this Amendment.
