RE: Authority for the County of Westchester to enter into a Grant Agreement

with the Federal Transit Administration ("FTA") for \$400,000.00 in Federal Transit Capital Assistance (Grant Agreement NY 2022-016-00).

Authority is requested for the County of Westchester (the "County") to enter into an agreement with the Federal Transit Administration ("FTA") for \$400,000.00 in Federal Transit Capital Assistance. A 20% County match is required to receive the FTA funds for a total of \$100,000.00. The funding sources are broken down as follows:

Funds received from this grant will be utilized as follows:

Real Time Digital Sign System (\$400,000.00 Federal)

Federal funds in this grant are being provided from the FTA to install a fully operational real-time digital sign system including all necessary hardware and software that will interface and connect with Bee-Line and County equipment and systems. It is anticipated that signs will be installed at up to ten (10) locations throughout the County.

The goal of this project is to provide current information related to bus service.

The receipt of reimbursement funds will be monitored by both the Department of Public Works and Transportation and the Department of Finance.
