Riviezzo Contracting is being requested to do Tree Removal. It should be noted that Papitto Construction Co., Inc. additionally canvassed TGW Landscaping and Contracting, a MBE firm, and Walker Tree Care, Inc., a WBE firm, for Tree Removal; however, TGW Landscaping and Contracting does not have the relevant experience with the type or quantity of work being requested, and Walker Tree Care, Inc. responded as not interested.

Campanella Fence is being requested to do Fence Work. It should be noted that Papitto Construction Co., Inc. additionally canvassed two (2) WBE firms: Yaboo Fence Co. and Mohegan Associates, Inc. for Fence Work; however, Yaboo Fence Co. cannot accommodate the required contract schedule, and Mohegan Associates, Inc. responded as not interested.

The listed Subcontractors have been investigated, and the Department recommends approval.
