YMOND SCULKY, SECRETARY Resolution authorizing the County of Westchester, acting by and through its Department RE: of Laboratories and Research, to enter into an agreement with the Regeneron Pharmaceuticals, Inc. pursuant to which the County will provide analytical water testing services to check for bacterial and chemical contaminants for the term commencing May 1, 2022 and terminating April 30, 2023 in an amount not to exceed \$100,000, payable pursuant to a set fee schedule

The attached resolution, if approved by your Honorable Board, would authorize the County of Westchester (the "County"), acting by and through its Department of Laboratories and Research (the "Department"), to enter into an agreement with Regeneron Pharmaceuticals, Inc. ("Regeneron") to provide analytical testing services for Regeneron's industrial reverse osmosis de-ionized water system to check for bacterial and chemical contaminants, for the term commencing May 1, 2022 and terminating April 30, 2023 man amount not to exceed One Hundred Thousand (\$100,000) Dollars, to be paid pursuant to the County's set fee schedule for these services ("Agreement").

This is a new agreement, and the Department has the capacity to provide these needed testing services to Regeneron. The provision of the testing provided for in the proposed Agreement will protect the public at large by assuring that the reverse osmosis water system is monitored to assure that bacteria and chemicals are at acceptable levels.

The Agreement will serve a public purpose by providing necessary water testing for Regeneron's industrial reverse osmosis de-ionized water system.

The proposed Agreement is not a procurement as it is revenue generating and therefore the County Procurement Policy does not apply.

Since the County is able to perform these testing services for Regeneron, I most respectfully request that your Honorable Board approve the attached proposed Resolution.
