Authority of your Honorable Board is requested for the County of Westchester ("County"), acting by and through Westchester Community College ("College"), through its Physical Plant Department ("Department"), to enter into Agreement No. WCC-22-935 ("Agreement") with Barile Gallagher & Associates Consulting Engineers, PC ("Consultant"), 39 Marble Avenue, Pleasantville, NY 10570, in connection with engineering services for the Administration Building Renovation, Westchester Community College, Valhalla, New York. The Consultant shall provide design services associated with this project. Design services shall include the preparation of construction contract documents (drawings and specifications), construction cost estimates, any required addenda, and a bid analysis including an evaluation of the bids to determine compliance with bidding requirements and whether the bidders are responsible so that the County may recommend award of the construction contracts. In addition, the Consultant shall provide design services during construction consisting of shop drawing and submittal review, attendance at project meetings, periodic site visits and preparation of as-built drawings.

The objective of this project will be to renovate the Administration Building's HVAC and Plumbing systems. The program will need to be developed with the implementation team composed of the Physical Plant Department. The renovation will meet the needs of the college and cost estimates of construction at each phase of design (30/60/90) will be provided.

On December 13, 2021, the Professional Prequalification Board was canvassed for the purpose of generating an eligible list of qualified firms to provide engineering services for this project. The Professional Prequalification Board approved a list of seven (7) qualified firms. As the fee is estimated to be less than \$250,000, the list was reviewed by the Professional Selection Board on June 14, 2022, whereby three firms were selected to possibly perform said services.

By Resolution approved July 21, 2022, your Honorable Board authorized the County to negotiate with the Consultant and a proposal was submitted for engineering services for the Administration Building Renovation, Westchester Community College, Valhalla, New York, for a total fee of \$125,000.00, pursuant to an approved budget.

RESOLVED, that the County of Westchester ("County"), acting by and through Westchester Community College ("College"), through its Physical Plant Department ("Department"), is authorized to enter into Agreement No. WCC-22-935 ("Agreement") with the firm of Barile Gallagher & Associates Consulting Engineers, PC ("Consultant"), 39 Marble Avenue, Pleasantville, NY 10570, in connection with engineering services for the Administration Building Renovation, Westchester Community College, Valhalla, New York. The Consultant shall provide design services associated with this project. Design services shall include the preparation of construction contract documents (drawings and specifications), construction cost estimates, any required addenda, and a bid analysis including an evaluation of the bids to determine compliance with bidding requirements and whether the bidders are responsible so that the County may recommend award of the construction contracts. In addition, the Consultant shall provide design services during construction consisting of shop drawing and submittal review, attendance at project meetings, periodic site visits and preparation of as-built drawings; and be it further

RESOLVED, that for services rendered in accordance with the Consultant's proposal, a total compensation of \$125,000.00 shall be provided, pursuant to an approved budget; and be it further

RESOLVED, that the Agreement shall commence upon the Consultant's receipt of written notice from the Director of the Physical Plant Department or his designee and that the completion date shall be December 31, 2024; and be it further

RESOLVED, that the President of Westchester Community College or his duly authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
