ND SCULKY, SECRETARY Authority for the County of Westchester to enter into an agreement with Tony Re: Orlando Productions, LLC for the performance of a concert at the Westchester County Center on July 21, 2023 in an amount not & exceed \$50,000 and to enter into an agreement with Coda Productions for the performance of a concert at the Westchester County Center on July 21, 2023 in an amount not to exceed \$42,500.

In conjunction with the 105th Angual American Legion Convention being held in Westchester County July 17th through 23rd, 2023, the County of Westchester (the County") requests authority to enter into an agreement with Tony Orlando Productions, LLC ("TO") for the performance of a concert at the Westchester County Center on July 21, 2023 (the "Concert") in an amount not to exceed \$50,000. Authority is also being requested to enter into an agreement with Coda Productions ("Coda") to provide additional musical entertainment at the Concert in an amount not to exceed \$42,500. The Concert will include a performance by Tony Orlando along with an additional lineup including: Just Nuts, The Chiclettes, The Drifters, Dennis Tufano, Bobby Wilson and Jay and the Americans. The Concert will be promoted along with the 105th Annual American Legion Convention and approximately 800 tickets will be provided free of charge to veterans. Additional tickets to the concert will be sold by Ticketmaster. Revenue Ofrom the ticket sales will offset the costs associated with the Concert.

The County is promoting this concert and the agreement provides that the County will defend and indemnify TO as follows:

"The County will indemnify, defend, and hold harmless all of Artist and Artist's accountants, attorneys, agents, representatives, and their respective contractors, employees, licensees, and designees harmless from and against any and all third-party claims, liability, and/or loss arising out of or in connection with the [County's security and safety] obligation."

The proposed Concert will be a welcome conclusion to the American Legion Convention and will provide entertainment to veterans as well as to the general public. The performance of TO and Coda pursuant to the proposed agreements will be tracked and monitored the Department of Parks, Recreation and Conservation, by County Center staff.
